
# Shoplifting Increases Despite Overall Decline in Crimes Against Property: Mid-Year 2024

As part of an agreement with local law enforcement agencies in San Diego County, the SANDAG Criminal Justice Clearinghouse collects and reports regional crime statistics twice a year, highlighting trends and drawing comparisons to previous years. Following the recent release of **Crime in the San Diego Region Mid-Year 2024**, this CJ Flash highlights a recent rise in shoplifting amid a general decline in crimes against property, analyzing one- and three-year trends.

## Highlight 1: Sharp increase in shoplifting incidents since mid-year 2021

Over the past few years, shoplifting has experienced a significant surge in the region.<sup>1</sup> From mid-year 2021 (January to June) to mid-year 2024, incidents of shoplifting reported to regional law enforcement have risen by 64%. Notably, shoplifting now constitutes 20% of all reported larcenies, up from 11% in mid-2021 (not shown).


Figure 1: Number of shoplifting incidents (mid-year 2021, 2023 and 2024)

### Highlight 2: Decline in thefts from motor vehicles drives larceny decrease

While shoplifting has been on the rise, overall larceny offenses in the region have actually declined by 10% since mid-year 2021. This decrease is largely attributed to a sharp drop in thefts from motor vehicles, which fell by 40%—from 7,928 incidents in mid-2021 to 4,791 by mid-2024, pointing to a shifting landscape in larceny trends.




#### Figure 2: Rate changes across types of larcenies (mid-year 2021 to 2024)<sup>2</sup>

<sup>1</sup> It is possible that shoplifting counts in 2021 were influenced by pandemic-related store closures and quarantines, contributing to the perception of a significant rise in incidents once stores reopened. <sup>2</sup> Offenses with relatively low number of reported incidents are not included. A full list of incident counts can be found in the CJ Bulletin **Crime in the San Diego Region Mid-Year 2024**. Additionally, percent changes may not accurately reflect the scale of change (i.e., pocket-picking and purse-snatching each represent less than 100 incidents).


## Highlight 3: Broader decline in crimes against property since mid-2021

In the first half of 2024, regional law enforcement reported 36,071 property crime incidents, marking a 7% decrease from mid-year 2023 and a 14% drop from mid-year 2021. Almost all crime against property categories saw reductions, with the exception of robberies, which experienced a marginal increase of less than 1%. While nearly all crimes against property categories have experienced decreases, shoplifting stands out as one of the few exceptions.<sup>3</sup>
