The ITOC Selection Committee also reappointed Mr. Kai Ramer to continue serving in the position of Licensed Engineer through May 2020, Mr. Dustin Fuller to continue serving in the position of Biology/Environmental Science through May 2023, and Mr. Stewart Halpern to continue serving in the position of Municipal/Public Finance through May 2023.
