On October19, 2021, the motor vehicle emissions budgets from the 2020 SIP were found adequate by U.S. Environmental Protection Agency for transportation conformity purposes (86FR 54692). An update on the approval process and implementation of this plan will be provided.

October 6, 2021, Meeting Minutes

Sam Sanford (SANDAG), called the meeting of the San Diego Region Conformity Working Group (CWG) to order at 10:32 a.m.

1. Welcome and Introductions

Sam Sanford facilitated introductions. The attendance sheet for this meeting is included.

2. Meeting Minutes (Information)

Sam Sanford asked the CWG to review the minutes from its September 1, 2021, meeting. No comments or corrections were made.

3. Public Comments/Communications/Member Comments (Discussion)

Stephanie Parent (California Air Resources Board [CARB]) commented on a follow-up item from the September meeting on economic impact analysis in the 2022 State Strategy for the State Implementation Plan (State SIP Strategy). CARB will perform statewide economic impact analysis as part of the State SIP Strategy but will not be performing sub-regional economic impact analysis as part of this effort.

Richard Radcliffe (SANDAG) announced that SANDAG is working on Amendment No. 6 for the 2021 Regional Transportation Improvement Program (RTIP). This amendment includes air quality conformity analysis and aligns the 2021 RTIP with the 2021 Regional Plan. The draft amendment will be released for public review on October 19, 2021. The draft schedule for the 2023 RTIP update will be presented to the CWG at a future meeting.

Nick Cormier (San Diego Air Pollution Control District [APCD]) announced that there is a virtual public workshop on October 6, 2021 at 4:00 pm for initial scoping for the next revision of the state ozone plan.

4. San Diego Forward: The 2021 Regional Plan (Discussion)

Sam Sanford provided an update on San Diego Forward: the 2021 Regional Plan. The draft plan is currently posted to SDForward.com and was open for public comment through August 6, 2021. SANDAG is responding to comments and will compile responses into Appendix G: Public Involvement Plan to the proposed final plan. Comments and responses will be presented to the Board of Directors at an October 29, 2021, meeting.

On September 24, 2021, SANDAG shared a revised version of the 2021 Regional Plan's Appendix C: Air Quality Planning and Transportation Conformity with the CWG. Comments on the revised draft air quality conformity documentation are requested by October 25, 2021, which completes the 30-day review period per interagency consultation procedures.

On October 4, 2021, the U.S. EPA published the adequacy finding for transportation conformity purposes of the emission budgets submitted in the 2020 SIP for San Diego. The finding is effective October 19, 2021. The air quality conformity documentation for the proposed final 2021 Regional Plan will be updated to reflect the new adequate budgets.

Dawn Vettese (SANDAG) presented an updated version of revenue forecasts that will be included in proposed final 2021 Regional Plan. New revenue streams, including those expected to be created in the future, are included in the Plan. Attachment 4 on this meeting's agenda has the list of existing and future revenue sources, including assumptions used. The revenue assumptions were revised between draft and proposed final versions of the plan, including updates to sales taxes and road usage charge implementation dates, forecast vehicle miles traveled based on the implementation of managed lanes and other projects, and assumptions for financing and leveraging local funding for state and federal funding.

Danielle Kochman clarified that the state-level component of the road usage charge is assumed to be revenue-neutral, while the regional-level component of the road usage charge is expected to be used to fund transportation projects and programs within the region.

Elisa Arias clarified that while certain funding sources assumed in the plan are contingent on successful ballot measures, the plan's assumptions are based on historical performance of similar measures. Additionally, unforeseen funding sources may become available within the plan's horizon year of 2050.

5. 2020 Ozone State Implementation Plan Update (Information)

Nick Cormier (APCD) provided an update on the approval process for the 2020 SIP. On October 4, 2021, the U.S. EPA reported that the plan's motor vehicle emissions budgets were found adequate for transportation conformity purposes for the 2008 and 2015 ozone national ambient air quality standards.

6. EMFAC2021 Update (Information)

Kevin Hendrawan (CARB) provided an update on the development and approval process for both EMFAC2021 and EMFAC2017 adjustment factors. EMFAC2021 and updated EMFAC2017 adjustment factors have been submitted to the U.S. EPA for review and action.

7. Reconsideration of Safe Vehicles Rule Part One (Information)

Sam Sanford announced that on September 3, 2021, the U.S. Department of Transportation's National Highway Traffic Safety Administration (NHTSA) published the notice of proposed rulemaking on the Corporate Average Fuel Economy Standards for Model Years 2024–2026 Passenger Cars and Light Trucks. Comments are due by October 26, 2021, to NHTSA.

of this ICR to 4146, primarily as a result of consolidating this ICR with ICR 2060–0706. No Subpart B facilities were reporting at the time of the last renewal in 2018, however, the Agency identified two respondents that are likely to submit annual reports in 2021, and two responses were added to the ICR, adding 460 hours of labor and \$10,600 of nonlabor cost to the burden that was approved in 2019. For Subparts K, R, and W, there were no changes to the number of respondents, the annual time burden, or the annual non-labor cost compared to the most recent renewals of these ICRs.¹ The requested burden reflects the sum of the two ICRs that are being consolidated.

Adequacy Status of Motor Vehicle Emissions Budgets in Submitted 8-Hour Ozone Attainment Plan for San Diego; California

AGENCY: Environmental Protection Agency (EPA).

ACTION: Notice of adequacy.

SUMMARY: The Environmental Protection Agency (EPA or "Agency") is notifying the public that the Agency has found motor vehicle emissions budgets ("budgets") adequate in a California state implementation plan (SIP) submittal for San Diego County. Specifically, our finding relates to budgets in the area's "2020 Plan for Attaining the National Ambient Air Quality Standards for Ozone in San Diego County (October 2020)" ("2020 San Diego Ozone Plan" or "plan"). We find that these budgets are adequate for transportation conformity purposes for the 2008 and 2015 ozone national ambient air quality standards (NAAQS). Upon the effective date of this notice of adequacy, prior budgets for the 2008 ozone NAAQS previously found adequate by the EPA will no longer be applicable for transportation conformity purposes, and the San Diego Association of Governments (SANDAG) and the U.S. Department of Transportation must use these adequate budgets in future transportation conformity determinations.

DATES: This finding is effective October 19, 2021.

SUPPLEMENTARY INFORMATION:

Throughout this document, whenever "we," "us," or "our" is used, we mean the EPA.

Today's notice is simply an announcement of a finding that we have already made. The California Air Resources Board (CARB) submitted the plan to the EPA on January 12, 2021, as a revision to the California SIP. The plan contains budgets for both the 2008 and the 2015 ozone NAAQS. These budgets are used for the 2008 ozone NAAQS reasonable further progress (RFP) milestone years 2020 and 2023 and for the attainment year 2026. For the 2015 ozone NAAQS, these budgets are used for RFP milestone years 2023, 2026, and 2029, and for the attainment year 2032.

The EPA sent a letter to CARB dated September 21, 2021 stating that the motor vehicle emissions budgets in the submitted 2020 San Diego Ozone Plan are adequate for transportation conformity purposes. The finding is available at the EPA's conformity website. We announced availability of the plan and related budgets on the EPA's transportation conformity website on June 4, 2021, requesting comments by July 6, 2021. We received no comments in response to the adequacy review posting. The adequate budgets are provided in the following tables:

Transportation conformity is required by Clean Air Act section 176(c). The EPA's conformity rule requires that transportation plans, transportation improvement programs, and transportation projects conform to a state's air quality SIP and establishes the criteria and procedures for determining whether or not they conform. Conformity to a SIP means that transportation activities will not produce new air quality violations, worsen existing violations, or delay timely attainment of the NAAQS.

The criteria we use to determine whether a SIP's motor vehicle emissions budgets are adequate for conformity purposes are outlined in 40 CFR 93.118(e)(4), promulgated on August 15, 1997.3 We have further described our process for determining the adequacy of submitted SIP budgets in our final rule dated July 1, 2004, and we used the information in these resources in making our adequacy determination.4 Please note that an adequacy review is separate from the EPA's completeness review and should not be used to prejudge the EPA's ultimate action on the SIP submittal. Even if we find a budget adequate, the SIP submittal could later be disapproved.

Pursuant to 40 CFR 93.104(e), within two years of the effective date of this notice, SANDAG and the U.S. Department of Transportation will need to demonstrate conformity to the new budgets if the demonstration has not already been made. 5 For demonstrating conformity to the budgets in this plan, the on-road motor vehicle emissions from implementation of the transportation plan or program should be projected consistently with the budgets in this plan, i.e., by taking the county's emissions results derived from CARB's EMFAC model (short for EMission FACtor) and then rounding
