New Grant Funding: Project Safe Neighborhoods Fiscal Agent

Overview

As part of Project Safe Neighborhoods (PSN), funding support from the U.S. Department of Justice (DOJ) is allocated to the 94 federal judicial districts nationally to establish collaborative teams to implement a strategic plan for investigating, prosecuting, and preventing violent crimes in their respective districts. Because the U.S. Attorney's Offices in these districts are unable to directly accept the funding, a fiscal agent for each of the districts is required to oversee the distribution and use of the funding. In 2021, the four districts in California asked SANDAG to serve as their fiscal agent to apply for and accept FFY 2021 PSN funding.

Key Considerations

As the fiscal agent, SANDAG will work with the Southern District of California to administer its \$185,384 in funding (Overall Work Program [OWP] 2353700), the Central District of California to administer its \$915,514 in funding (OWP 2353800), the Northern District of California to administer its \$409,699 in funding (OWP 2353900), and the Eastern District of California to administer its \$432,273 in funding (OWP 2354000). As the fiscal agent, SANDAG will organize, draft, and support the required PSN application and subaward materials; manage all fiscal matters; prepare required federal reports; work with Bureau of Justice Assistance staff to submit Grant Adjustment Notices as needed; work with federal monitors or auditors; and establish a process to award and monitor each subaward to ensure the subaward adheres to financial and administrative rules. SANDAG has previously served as the fiscal agent for the Southern District of California and has the experience and ability to successfully manage these federal funds. Ten percent of the funds received are allocated to reimburse SANDAG for its fiscal agent responsibilities. The Southern District of California requested SANDAG serve in this role for the other districts given SANDAG's prior experience locally, as well as its role as the Clearinghouse for crime information useful for the region.

Action: Recommend

The Public Safety Committee is asked to recommend that the Board of Directors approve a budget amendment to the FY 2022 Overall Work Program and Budget to accept \$1.94 million in funding on behalf of four U.S. Attorney's Offices in California from the U.S. Department of Justice.

Fiscal Impact:

A total of \$1.94 million (2353700, 2353800, 2353900, and 2354000) will be added to the FY 2022 Program Budget to implement gun violence activities, and SANDAG will receive 10% of the funding to serve as the fiscal agent.

Schedule/Scope Impact:

The new funding will support activities in the four U.S. Attorney districts in California for up to three years.

Next Steps

Pending Public Safety Committee approval, SANDAG staff will amend the FY 2022 SANDAG OWP and Budget to accept the \$1,942,870 in federal funding and work with each of the four U.S. Attorney's Offices to fulfill the fiscal agent responsibilities.

New Grant Funding: County Data-Driven Study: Alternatives to Incarceration

Overview

In December 2021, SANDAG responded to a Request for Proposals (RFP) from the County of San Diego entitled “Data-Driven Approach to Protecting Public Safety, Improving and Expanding Rehabilitative Treatment and Services, and Advancing Equity Through Alternatives to Incarceration.” SANDAG was notified by the County that it was selected for this contract, pending successful negotiations.

Key Considerations

The County of San Diego released this RFP with an interest of partnering with a research entity who would be able to compile data and work with stakeholders to conduct a data-driven approach to identifying the primary policy drivers of reduced incarceration rates during the period of the COVID-19 pandemic. As part of this effort, SANDAG will identify available data; analyze jail population changes; conduct a gap analysis related to services and supports; review best evidence-based practices; make recommendations that incorporate feedback from diverse groups; prepare a comprehensive fiscal analysis; and publish a series of written reports and updates.

SANDAG and its Criminal Justice Clearinghouse have experience conducting analysis of jail populations; reviewing public safety outcome data; conducting research and preparing recommendations regarding community services and supports; and preparing fiscal analyses regarding the costs, savings, and long-term fiscal impacts results from investment in alternatives to incarceration.

Next Steps

Pending Public Safety Committee approval, SANDAG staff will amend the FY 2022 SANDAG Overall Work Program and Budget to accept the \$300,000 in County funding, pending successful contract negotiations.

New Grant Funding: Bureau of Justice Assistance Smart Policing Initiative

Overview

In 2015, California passed Assembly Bill 953 (Weber), the Racial and Identity Profiling Act (RIPA) that required each law enforcement agency that employs peace officers to annually report data on all stops to the Attorney General, with the goal of preventing racial profiling and disparity. The Chula Vista Police Department (CVPD) will be one of the agencies required to begin compiling and reporting this information in January 2022. With rising violent crime rates and an increased call for greater police transparency, the CVPD and SANDAG partnered on a grant request to the Bureau of Justice Assistance (BJA) that would support the partners in effectively and efficiently tracking required RIPA data, utilizing these data to inform areas for improvement, and document if desired outcomes are achieved.

Key Considerations

SANDAG has worked with the CVPD through its work on the Criminal Justice Clearinghouse, as well as on other research efforts that include conducting community surveys and successfully receiving Proposition 64 funding through the State of California.

The primary goals of this three-year project include: (1) utilizing new data sources and technology as part of a Scan, Analyze, Response, Assess (SARA) model to understand who the CVPD stops and interacts with; (2) identifying possible disparities and regularly sharing this information with the community; (3) addressing risk factors that could contribute to disparity through targeted interventions; and (4) documenting the effectiveness of interventions and creating a practitioner toolkit for other jurisdictions.

SANDAG has previously been the successful recipient of BJA Smart Policing, Smart Probation, and Smart Prosecution funding and is familiar with federal funding requirements.

Next Steps

Pending Public Safety Committee approval, SANDAG staff will amend the FY 2022 SANDAG Overall Work Program and Budget to accept the \$496,166 in federal funding and work with the CVPD to fulfill the goals and objectives of the grant.
